# **Prize Competition Rules**

## 1. The Prize Competition and the Organiser

The Rules below (hereinafter referred to as the "Competition Rules") shall regulate any competitions (hereinafter referred to as the "Competition") managed and maintained on our platform <a href="https://www.facebook.com/LAVYLITES.officialpage">https://www.facebook.com/LAVYLITES.officialpage</a> Facebook by Lavylites Worldwide Zrt. (Headquarters: 1053 Budapest, Veres Pálné utca 9. fszt., tax number: 26727080-2-41, company registration number: 01 10 140279) (hereinafter referred to as the "Organiser").

## 2. Who is eligible to participate in the Prize Competition?

- 2.1. The Prize Competition is open to any natural person over the age of 18 who is of full legal capacity (hereinafter referred to as the "Participant") and has a valid registration on www.facebook.com and on www.lavylites.com.
- 2.2. The Organiser's employees, collaborators, and their relatives, may not participate in the Competition in compliance with the provisions of the Civil Code Article 8:1 paragraph § (1), point 1.
- 2.3. By entering the Competition, the Participant irrevocably declares their intention to do so, undertakes the obligation to read the Competition Rules and agrees to the stipulated Rules as being legally binding. Participation in the Competition commences with the completion of the first activity (e.g. sharing the text content) as outlined in the announcement of the respective Competition.
- 2.4. Unless stated otherwise in the Competition post, the Participant is allowed to take part in the Competition on a single occasion only.
- 2.5. The conduct and participation in the Competition are subject to the current Rules. In the event the Competition Rules do not regulate a particular issue, the provisions in force of the applicable Rules shall prevail.

## 3. Duration and progress of the Competition

### 3.1. The Competition includes three posts:

3.1.1. 1st post: 30 July 2025

3.1.2. **2<sup>nd</sup> post:** 9 August 2025

3.1.3. **3<sup>rd</sup> post:** 16 August 2025

3.2. **Prize Draw:** 31 July, 10 August, 17 August 2025

3.3. Announcement of results: 31 July, 11 August, 18 August 2025

3.4. **Number of winners:** 3 participants (1 winner per post)

- 3.5. To enter the Prize Competition and be eligible for the prize, the Participant must comply with the maximum number of entry requirements as set out in the official invitation to the Competition published on the official Lavylites Worldwide Facebook social media channel:
- (i) The Participant shall follow the official Lavylites Worldwide Facebook social media channel.
- (ii) Entry in the Competition is conditioned by prior registration of the Participant on the website www.lavylites.com.
- (iii) Participants are required to respond to the question published on the official Facebook social media channel of Lavylites by commenting on the post within 24 hours of its publication. The Competition consists of three posts, all of which are related to Lavylites products and the 2025 Global Lavylites Event.

#### 4. Prizes and Winners

- 4.1. **Prizes:** 3 tickets for the Global Lavylites event will be drawn.
- 4.2. **Winners:** The winners will be selected by random draw from all those who have submitted a matching comment. Winners will be announced on the official Facebook social media channel of Lavylites.
- 4.3. The prize is not redeemable for cash.
- 4.4. The Winners will be selected by a random draw using the Social Winner app (https://socialwinner.besocial.hu/).
- 4.5. Substitution of winners is against the current Rules.
- 4.6. Should the Winner be unable or unwilling to take the prize, the prize may be transferred to another individual once only, upon prior written notice to the Organiser. The transfer is subject to the agreement and mutual consent of the Organiser and the Winner.

#### 5. Notification of the Winner

- 5.1. The name of the Winner will be made public on the official Facebook social media channel of Lavylites. By participating in the Competition, the Participant expressly consents to this public announcement. Following the announcement of the results, the Winner must contact the Organiser via Facebook or by sending an email to social@lavylites.com.
- 5.2. In case the Winner fails to contact the Organiser within 30 days of the announcement of the results at the latest, the Winner will no longer be entitled to receive the prize. The Winner who does not contact the Organiser within the timeframe as specified above shall automatically and irrevocably waive any claim for damages, remuneration or other forms of compensation in conformity with the accepted Rules.
- 5.3. The Winner shall bear the full consequences of any misrepresentation or failure to receive emails in the inbox. The Organiser is unable to verify the accuracy of the information submitted upon registration for the Competition (or subsequently to it).

#### 6. Exclusion from the Competition

- 6.1. If the Participant or Winner fails to comply with the established Competition Rules, declines to accept or objects to the Rules or any of the provisions, they will be excluded from further participation. Furthermore, the Participant or the Winner who has registered on Facebook, or on the official Lavylites website in violation of or to circumvent the Facebook Terms of Use will be automatically excluded from the Competition.
- 6.2. Furthermore, the Participant who engages in unethical behaviour, and attempts to gain unfair advantage and increase their own chances of winning through deceptive means, thereby reducing the chances of winning for other participants who are playing fairly, will be excluded from the Competition. Any form of (computer) manipulation, the creation of massgenerated e-mail addresses or accounts, or behaviour that is incompatible with or contravenes the principles of the Competition, or reasonable suspicion thereof, will result in immediate exclusion from the Competition.
- 6.3. The Participant will be excluded from the Competition if their comments violate the rights or legitimate interests of the Organiser (including public comments of the Participant that violate the rights or legitimate interests of another person, furthermore of other people or social groups).

### 7. Responsibility of the Organiser

The Organiser does not guarantee the continuity of the Competition and may suspend or terminate it at any time and for any reason. The Organiser shall not be held liable for any damages resulting from technical failures of the Internet Service Provider or Facebook. The Organiser will endeavour to remedy any disruptions or malfunctions that may occur during the operation of the Competition but shall not be liable for them. The Organiser excludes all claims for any costs, damages, or losses resulting from or related to any errors, inadequacies, malfunctions, delays, or losses incurred during participation in the Competition.

### 8. Further provisions

- 8.1. The Organiser declares that the Competition does not fall under the scope of the Gambling Law, Act XXXIV of 1991.
- 8.2. The current Rules are governed by the Hungarian laws.
- 8.3. The Competition is independent of Facebook. Facebook does not participate in the Competition, nor supports it.
- 8.4. The Organiser reserves the right to withdraw or amend the Competition Rules at any time and for any reason.
- 8.5. The decisions of the Organiser are to be considered final in all Competitions and are not subject to appeal or review.

#### 9. Data management

### 9.1. Database Manager

Applicants shall proceed with entrance in the Prize Competition in accordance with the current Rules. The Participant shall provide their personal data during their registration and participation in the Competition. Furthermore, the Winner shall provide their personal data in connection with the receipt of the prize. The personal data manager responsible for processing the personal data is the Organiser:

## 9.2. Scope of the processing of personal data

The Organiser processes the personal data of the Participant in the Competition as outlined below:

- (i) In the case of Participants
- Facebook profile name
- (ii) In the case of Winners
- full name
- permanent address
- telephone number
- email address

### 9.3. The legal basis for the data processing

The Organiser processes the personal data of the Participant based on their voluntary consent (Article 6 (1) (a) of the GDPR). The Participant gives their consent for the Competition with their registration (by acting implicitly) as specified in the current Rules. Simultaneously with their consent, the Participant agrees that, in the event of winning, their name be made public on the Facebook social media channel of the Organiser.

## 9.4. Purpose of data processing

The Organizer processes the personal data of the Participant for the following purposes: participation in the Game, the drawing of the prizes, the coordination necessary to receive the prizes and to enable the delivery of the prizes.

## 9.5. Duration of data processing

The Organiser will process the personal data of the Participant for the duration of the Competition, as indicated in the current Rules.

Consent for the processing of personal data may be withdrawn at any time by the Participant via email to en@lavylites.com.

## 9.6. Cancellation of personal data

- 9.6.1. At the end of the Competition, the personal data of all Participants will be deleted, except for the personal data of the Winner. The personal data of the Winner will be stored by the Organiser for 8 years after the delivery/receipt of the prize, subject to applicable accounting requirements, after which it will be deleted.
- 9.6.2. Notwithstanding the aforementioned, the Organiser shall delete the personal data of the non-winning Participant on condition the Participant submits a request to the Organiser to <a href="https://huw.lavylites.com">huw.lavylites.com</a>.

## 9.7. Data Transmission(s), Data Processor(s)

Transmission of the personal data of the Participant to third parties is strictly prohibited, except from the part of the Organiser's employees responsible for the administration of the Competition. The Organiser uses Be Social Ltd. (registered office: 1037 Budapest, Seregély utca 3-5., company registration number: 01-09-997245, telephone number: +36 70 411 2343, e-mail address: info@besocial.hu) as a data processor for the purpose of conducting the lottery. Be Social Ltd., as the developer and operator of the Social Winner application, performs data processing activities, i.e. it processes the personal data of the Players on behalf of the Organiser, on behalf and in the interest of the Data Controller.

# 9.8. Data security

The Organiser shall adhere to the principle of data protection by design and by default, both in determining the method of data processing and during data processing. Furthermore, the Organiser shall adopt the appropriate technical and organisational measures to ensure that the data protection principles are implemented effectively and that the data processing incorporates the necessary guarantees to comply with the GDPR requirements and to protect the rights of the Participant. The Organiser shall ensure to process, by default, exclusively the personal data required for the specific purpose for which it is intended to be used. The aforementioned obligation relates to the quantity of personal data collected, the extent to which it is processed, the duration of its storage and availability. The Organiser shall implement data security measures to ensure that personal data is not made available to an indefinite number of persons without the intervention of a natural person.

## 9.9. Miscellaneous provisions

The Participant shall refer to the website (https://www.lavylites.com/hu/documents) for information on their rights in relation to the data management and the procedure for asserting claims, as well as on the Rules.
